Minutes of Lodge Meeting - Thursday, 14th November 2024

- The general meeting of the Perth Elks Lodge # 362 was held on Thursday, 14th November at 6:00 pm with ER Alan Young presiding.
- Sara Gamblin, Manager for Making a Difference Foodbank, was presented with a cheque for \$2029.25 which was raised from the Remembrance Day Breakfast
- Opening ceremony was conducted. ER Alan introduced Mitchel and Denise Grey, Centerville, attending tonight's meeting. He also acknowledged the large turnout, 25+% of the Lodge members.
- Adam Tutty was initiated as the newest member of the Lodge.
- ER Alan asked if everyone had read the minutes of the 10th of October 2024 meeting, and whether there were any questions, omissions, or errors. Ron Gaunce asked that the Minutes be read. The reading being done, Alan asked if there were any errors or emissions. There being none, a MOTION TO ACCEPT was made by Paul Kenney. SECONDED by Diane Hathaway. MOTION CARRIED.
- Treasures Report Gary Grant reported that our Scotia Bank account is in great shape. A MOTION TO ACCEPT the treasurer's report was made by Gary Grant. SECONDED by Paul Kenney. MOTION CARRIED.
- Committee Reports
 - Finance Al McPhail stated that Sue Turner is our new accountant and she will have a financial statement ready for the December Executive Meeting.
 - Bar Ron Dube reported on the non-alcoholic drinks now available. After some review by patrons the selection has been reduced to five beer, and 2 mixed drinks

Building

- I. Paul Kinney reported that someone backed into the ramp, damaging a couple of balusters. These will be replaced / repaired, and reflectors will be installed to hopefully prevent a similar issue in the future
- II. Paul stated that an LED dusk to dawn flood light had been installed on the roadside signpost. It illuminates the walkway and stairs very well.
- III. To enhance visibility rope lights will be installed under the ramp railing. The wall sconce lights on both sides of the main entry will be upgraded.
- IV. There is no timeline for installation of the railing. Jonny Gagnon highlighted the liability of people using the front entrance without a railing and the possibility of injury. A temporary railing will be installed in order to allow access until the permanent railing is installed.
- V. ER Alan recognized Paul and the other Lodge members for a job well done on the reconstruction of the front deck and access ramp.

Fundraising/Entertainment/Activities

- I. There being no Fundraising Committee Alan Young, Jamie Dooling and Anthony Davidson volunteered.
- II. A call for volunteers for the Village Senior Dinner and Wednesday Evening Fiddler's Supper went out and was filled.
- III. The Village Freeze Fest Committee has requested the Lodge run a snack bar during the function 15 / 16 Feb. It was agreed we would cook hot dogs and hamburgers, as well as provide pop and snacks.
