### Minutes of Lodge Meeting - Thursday, 10th October 2024



- 1. The general meeting of the Perth Elks Lodge # 362 was held on Thursday, 10<sup>th</sup> October at 6:00 pm with LK Jamie Dooling presiding.
- 2. Opening ceremony was conducted.

#### 5. Committee Reports

- Finance Mark Johnson spoke on the presentation made to the Charity Committee and Executive 2 Oct highlighting how the Lodge finances will be reported. Mark stressed the requirement to report all incoming funds through fundraising, so it can be reported properly and the Lodge to receive recognition for these donations. This will continue to put a positive light on the Lodge. Gary highlighted how much the Building committee has spent on material to build the front deck and access ramp to date. All labour has been via volunteers. Gary Grant MOVED to accept the Finance Report, SECONDED by Paul Kinney, MOTION CARRIED
- Bar Ron Dube stated that bar sales were down through the summer.
  - He asked for ideas to create opportunities to entice patrons. Jamie stated that he met with promoter Mitch Biggar with the intent to organize and promote acts like those who performed at the Oak Tree. The promoter would utilize the Lodge, cover expenses of the act through. His profit would come form the take at the door. The lodge profit would come from the bar,

  - IV. A comedy night.

Ron Gaunce stated that an Entertainment Committee would be required to coordinate such events. A call for volunteers will be sent out to all Lodge members.

## Building

- I. Paul Kinney reported on the ongoing construction. He stated the Building Committee voted to hire White's Precast to replace the railing on the front concrete steps and install new railing on the deck. After discussion about other acquired estimates and choice of material Paul MOVED to approve the funds to hire White's for the installation. SECONDED by Gary Grant. MOTION CARRIED.
- II. Paul also confirmed that a new LED dusk-to-dawn flood light has been ordered to mount on the street side sing post to illuminate the stairs.
- Fundraising/Entertainment/Activities

- I. The Elks Lodge and Rotary Club will jointly host a fundraiser breakfast in support of the Christmas Cheer program on 26<sup>th</sup> Oct. Expenses will be slit evenly between both organizations and 100% of profits will go toward the Christmas Cheer Program.
- II. The Lodge will host the Valley Horse and Saddle Club with a lasagna supper on 26<sup>th</sup> Oct.
- III. October fundraiser 50/50 squares. The draw will take place Fri 25 Oct. There are still several squares left to sell. A push will be made to sell all over the next 2 weeks.
- IV. The Lodge will host the Remembrance Day breakfast again this year. A call for volunteers for the three events was made and well received.

## Charities

Gary Grant reiterated that the joint Christmas Cheer breakfast fundraiser will follow the finance directive. He also stated that 55% of the assigned funding for charitable donations have been donated or earmarked.

- Wellness Diane Hathaway reported that one card had been presented to Gary Grant for a speedy recovery.
