
Minutes of Lodge Meeting – Thursday, 8th January 2026

 - ii. Gary MOVED and Wanda Allard SECONDED a request to ask the Executive to authorize the Treasurer to increase daily fund transfer maximum from \$500 to \$2500. Wanda questioned why a one-time payment could not be made? Gary stated that this is not possible as we have a business account. Franck Allard questioned if our account has ever been at risk? Gary stated it had not. Paul Kinney asked if this was a Lodge or Lottery issue? Gary stated that the lottery winnings had been deposited into the Lodge account in order to transfer the funds to the winner, who is out of the country for the winter.
